Objectives and way forward in addressing relevant challenges within the CBD (project Task 1.1)

Overall aim: Identify and prioritize issues for CBD NFPs in EU Member States and Associated countries, to address challenges within the CBD and its implementation

Detect knowledge needs relevant for the CBD agenda

Prioritize knowledge needs Identify best formats for expert support to CBD delegations

Potentially identify new and emerging issues



- Two rounds of workshops with NFPs: March 2023 and February 2024
- Online surveys
- Cooperation with existing processes (e.g., Vilm, WPIEI)



Comprehensive publicly available report with the outcomes of this process: November 2024

- Two days identical agenda: 24 and 27 March 2023
- Organized by **NINA and Syke**, with support of CER, **UNEP WCMC, RBINS**
- Aim: Identification of CBD-relevant knowledge needs and best formats for expert support

- 50 participants from 20 EU Member States and Associated countries + FC
- Geographically determined working groups (CEE-EU, 2xCEE-AC, Northern Europe, Western Europe)

Online survey

- Complementary **survey**: 32 responses from 18 countries
- CBD NFPs, SBSTTA NFPs, other CBD delegates
- EU Member States and Associated countries
- Workshops' participants and others
- 21 April 22 June 2023
- A well-balanced mix of different levels of experience
- Mainly from small CBD delegations (1-5 members)

Prioritized 'other' CBD agenda items

- 1. Global Biodiversity Framework (GBF)
- 2. Digital sequence information (DSI) on genetic resources
- 3. Mainstreaming of biodiversity within and across sectors
- 4. Marine and coastal biodiversity
- 5. Mechanisms for planning, monitoring, reporting and review
- 6. Resource mobilization and the financial mechanism
- 7. Biodiversity and agriculture
- 8. Biodiversity and health



Preliminary results: Knowledge and capacity needs

New issues requiring knowledge improvement:

- Baseline scientific information for planning the national targets
- Pollution and restoration
- Analysis of cross-cutting issues and how they interact
- Valuation of biodiversity
- Gender and biodiversity
- Soil biodiversity
- The effects of natural disasters on biodiversity
- Nature-based solutions

Some countries face challenges related to capacity and internal processes, as they lack:

- Intersectoral collaboration
- Human capacity
- Number of experts
- Financial resources (for implementation of GBF, travelling to COP with more experts, ...)
- Expertise in emerging issues (OECMs, DSI, ...)
- Synthesis of relevant scientific information



Preliminary results: Best formats for expert support



Most frequently noted information format for preparing for CBD negotiations
