New IPBES assessments released

IPBES' 11th Plenary, held in Windhoek, Namibia, concluded in December 2024 with the approval and unveiling of two reports with critical significance to global biodiversity governance:

The **Nexus Assessment** is meant to analyse the links between biodiversity, water, food, health and climate and mainstream them into biodiversity decision-making. The Transformative Change Assessment lays out the transborder changes needed to reverse the biodiversity decline felt across the globe.
