



The Kunming-Montreal Global Biodiversity Framework

COP 15 adopted a package of decisions to guide and support the implementation of the Framework:



Decision 15/8 includes the establishment of a **technical and scientific cooperation (TSC) mechanism** consisting of a network of regional and/or subregional support centres, to be coordinated by a global coordination entity

Strengthen institutional capacities to facilitate TSC

Facilitate knowledge sharing and learning


Regional Centres: 42 applications were received

- 12 applications from Africa
- 7 applications from Asia Pacific
- 4 applications from CEE
- 9 applications from GRULAC
- 10 applications from WEOG

Outcomes of the assessment published in the online IAG meeting held on **1-2 November 2023**.

During the online meeting we also discussed the proposed **assessment matrix and methodology** for the second stage of the process.

IAG and the challenges of the GBF

- ❑ GBF is a unique opportunity for strengthening collaboration, knowledge transfer and capacity building around a **common objective – GBF**.
- ❑ Complex networks require effective **coordination**: a Global Knowledge Support Service for Biodiversity will be essential (*it does not need to be large!*).
- ❑ Main resources must go to **build and develop capacities** of Parties and major groups
